The Environmental Commission continues to accept nominations for the Climate Smart Award Program. Nominees can be individuals or businesses that have displayed environmental stewardship in their home or in the community. Nominations close in April. Visit the <u>Environmental Commission's page</u> on the city website to make a nomination.

Last year's winner was the TUSD Nutrition Services Department for their "Smaller Footprints" program which implemented the use of compostable food trays, cutlery and napkins in cafeterias, as well as separate bins for recyclables, compostables, and landfill. Additionally, food that would otherwise be thrown away is diverted to a non-profit Food Finders program.

This quarter (January – March), the Torrance Village has a particular need for new socks and underwear (men's size large or xlarge), and new or gently used umbrellas.

What's the Latest on the Airport?

Torrance City Council approved a number of motions at the July 25, 2023, City Council meeting to help alleviate noise around the airport:

- Implement landing fees for all transient aircraft and flight schools with fleets of 3 or more. Robinson Helicopter exempt.
- Request a voluntary Letter of Agreement be signed by the Torrancebased flight schools for training at the airport.
- Conduct a noise study with the potential of expanding the current noise abatement monitoring system around the airport.
- Modify the hours of touch and go's, taxi back, and low approaches to only be allowed Monday Friday, 10:00 a.m. 6:00 p.m. No training allowed on holidays.
- Enforce Resolution 77-215, which allows a maximum of 6 flight schools.
- Enforce the early left turn requirement.
- Provide a report on phasing out of leaded gas within 12 months.

Here are some updates to the July 2023 motions since then:

- Limiting the number of flight schools to 6 meant that Sling Academy, the largest flight school and the seventh one to sign on, would not have its 2024 permit renewed. However, on January 9, the flight school won a preliminary injunction against Torrance allowing it to continue operating out of Torrance all this year. There are plans to go to trial.
- Instead of just limiting the hours of touch-and-go's, the City Council approved the banning of touch-and-go's on January 23, 2024.

Local Zoning Control Efforts Continue

Despite the end of the effort to get a proposition on the November 2024 ballot to reinstate local zoning control, there are still lawsuits in the works. In fact, one of the lawsuits has been filed by Torrance and 3 other local cities – Carson, Redondo Beach and Whittier. The premise of the lawsuit is that land use and single-family zoning are municipal (city-level) affairs and therefore cannot legally be dictated by the State according to the State's constitution.

The initial hearing for the case took place on September 9, 2023, where the judge took information under submission. On December 7, 2023, the judge issued an order requesting further information. The next (and hopefully final) hearing will be February 29, 2024.

Two other local cities have filed a lawsuit as well – Lakewood and Rancho Palos Verdes.

At the January 18 and February 5 School Board Meetings, the Board:

- Recognized the West High Girls Cross Country team's historic season. They finished as Pioneer League Champions, and went to the CIF Finals for the 7th straight year.
- Recognized the outstanding efforts of the West High Boys Cross Country team runners Andrew Quast and Ryan Hebers who both qualified for the State Cross Country Meet.
- Extended the employment contracts for the Superintendent, Chief Business Officer, and Chief Academic Officer through June 30, 2027.
- Heard an update on the Governor's Proposed Budget for 2024- 2025.
- Accepted the Independent Auditor's Report as of June 30, 2023.

In other District news, TUSD:

- Announced that enrollment for Transitional Kindergarten and Kindergarten for the 2024 – 2025 school year begins on February 19 (online) and February 20 (in person) for west area elementary schools (including Anza). - Unveiled the newly updated Torrance Brand Identity and Logo. After 75 years of history with the traditional logo, the district unveiled a refreshed logo and an updated brand for TUSD.
